► **SECTION A: Application Fee • Application • Bio • Photos**

Not all applicants will be chosen to compete in the Pageant. This is phase 1 of the process.

- Completed and signed application form
- \$25.00 non-refundable application fee (via Cash, check, or money order)
- A vertical, full body recent photo (not more than 6 months old) wearing fitted clothing and a clear head shot. No hats or sunglasses. Photos should not be larger than 5x7 and not smaller than a 4x6. **Photos will not be returned.**
- Type a maximum of three paragraphs (size 12-14 font), including but not limited to the following:
 - How did you hear about the pageant?
 - Why do you want to be a contestant in the Pageant?
 - What is your approach to health and fitness, and how would you promote wellness as the Queen?
 - What is your height, weight, and numeric clothing sizes (top, pants, dress)?
 - Describe any community involvement?
 - What do you hope to gain from being a contestant?

6. I am of good health and of good moral character.
7. I now reside, or plan to reside, within 120 miles of Detroit as my permanent and primary residence for a period of at least (12) months after the 2020 Ms. Black Fit and Fine Beauty Pageant.
8. No one living in my household is currently employed by the Ms. Black Fit and Fine Beauty Pageant System.
